The Validator AVS is an innovative, state of the art system built on the foundation of the Validator 2000. The Validator AVS takes the Validator technology to new levels and expands the functionality of the current system to address current and future validation challenges.

In November 2015 we began shipment of the Validator AVS. With the introduction of the new Validator AVS, we also want to assure our large installed base of existing Validator 2000 users that, as we have done throughout our history, we plan to continue to provide support and allow them ample time to properly plan for their future and provide uninterrupted validations.

With this notice we are formally announcing that Kaye will continue to provide sales of new Validator 2000 and Validator 2000 Upgrades through to the end of 2016. Kaye will continue to provide repairs, parts and service for the Validator 2000 for a minimum of 5 years after discontinuation of sales.

Kaye has also, with the development of the Validator AVS, provided a bridge for customers utilizing existing Validator 2000 to move towards the new platform.

As part of the Validator AVS, Kaye has developed a Validator Console which is a hard, rugged tablet which is pre-programmed and dedicated for Validation utilizing Kaye products. The Console comes not only with Validator AVS software but also includes legacy software such as existing Validator 2000 software V3.62B.

The AVS Console also comes with a new software platform which includes a new Reporting Tool. The Reporting Tool is backward compatible with existing Validator 2000 study files.
